**A. Clinical Practice:**

- **EVALUATION:** Traditional Chinese Medicine (TCM) diagnostic methodology exam series (known as Four Examinations) used to determine symptoms, patterns, deficiencies, and disharmonies apparent in the body. Pulsology (Pulse Diagnosis), Tongue Diagnosis, Auricular Acu-Point Diagnosis, and computerized devices or equipment such as Meridian Systems Energy Analysis may be used. Lab tests, x-rays, medical reports and records may be requested and reviewed in conjunction with the comprehensive data acquired in Traditional Chinese Medicine for a complete and thorough evaluation.
- **TREATMENT:** Holistic regimen of Traditional Chinese Medicine, including: Acupuncture, Acupressure / Massage, Tui-Na (Chinese therapeutic massage), Qi-Gong treatment (energy balance therapy), Moxibustion, Cupping, and Chinese Herbal Complex Formula Treatment.
- **PATIENT EDUCATION :** Instruction in Tai-Chi / Qi-Gong, Meimen Pingshuai (Arm Swinging exercise), bar hanging, and other exercises for specific health conditions and general health maintenance. Lifestyle Consultation including diet, weight loss, and sleep patterns.
